

Cookie Policy for Sports Vape

This Cookie Policy explains how **ZAP Management LLC**, doing business as **Sports Vape** ("Company," "we," "us," and "our"), uses cookies and similar technologies to recognize you when you visit our website at <https://sportsvape.com> ("Website"). It explains what these technologies are and why we use them, as well as your rights to control our use of them.

1. What are cookies?

Cookies are small data files that are placed on your computer or mobile device when you visit a website. Cookies are widely used by website owners in order to make their websites work, or to work more efficiently, as well as to provide reporting information.

2. Why do we use cookies?

We use first-party and third-party cookies for several reasons. Some cookies are required for technical reasons in order for our Website to operate (e.g., age-verification gates and shopping cart functionality). Other cookies enable us to track and target the interests of our users to enhance the experience on our online platform.

3. Types of Cookies We Use

The specific types of cookies served through our Website and the purposes they perform are described below:

- **Essential Cookies:** These cookies are strictly necessary to provide you with services available through our Website. For Sports Vape, this includes:
 - **Age Verification:** Remembering that you have confirmed you are of legal smoking age (21+) to enter the site.
 - **Security:** To help prevent fraudulent activity.
 - **Shopping Cart:** Remembering the items you have added to your cart as you browse.
- **Performance and Functionality Cookies:** These cookies are used to enhance the performance and functionality of our Website but are non-essential to its use.
- **Analytics and Customization Cookies:** These cookies collect information that is used either in aggregate form to help us understand how our Website is being used (e.g., whether visitors are finding our Fargo or Grand Forks location pages) or to help us customize our Website for you.

- **Advertising Cookies:** These cookies are used to make advertising messages more relevant to you. (Note: Due to regulations on nicotine products, we limit the use of targeting cookies to comply with platform-specific advertising policies).

4. How can I control cookies?

You have the right to decide whether to accept or reject cookies. You can set or amend your web browser controls to accept or refuse cookies. If you choose to reject cookies, you may still use our website, though your access to some functionality and areas of our website (like the checkout process) may be restricted.
